Congratulations to third-year student **Karen Collier** , author of “The Value of Internships” which appeared in the Law Students’ Corner of the Kansas Bar Association Journal, Sept. 2008 p. 12. Karen wrote about her experiences in the **Elder Law Externship** during 2007-08, as well as a summer externship with the Sedgwick County District Attorney.

Students in the **Elder Law Externship** work with Kansas Legal Services offices to provide legal advice to senior citizens in Kansas. The Externship is directed by **Marilyn Harp**, KU Law Graduate and Executive Director of Kansas Legal Services.

Kansas Legal Services is also providing supervision for law students who are enrolled in the **Family Health Care Legal Services Clinic**. The law school’s newest clinic is a medical-legal collaboration in which indigent patients seeking medical care can also receive legal services. Students who participated in the initial semester observed how legal problems can impact health issues for low-income clients. Health issues and low incomes are common in the senior population, making this a very attractive clinical offering for the student interested in Elder Law.
